Hyacinthe: A Blue Gemstone

(1) Definition, Exodus 28:19, Rev. 21:20

The word “Hyacinthe” adopted here, and consecrated as the naming and title of a particular ministry is more commonly known as “the jacinth” in biblical context and is chosen to perpetuate and reflect a distinct objective of the kingdom of the Kingdom of God. The term in expression speaks of two things: The setting of stones, and in reflection the setting of gifts and talents from God in their place within the body and government of Christ and the preparation of the Church for Judgment that was borne daily upon the breast of the High Priest of the Nation; of which Christ is our High Priest after the Order of Melchisdec. The same term jacinth is the eleventh foundation of the foundation of the wall of the city of our God, revealed in Revelation; of which we are the Living City indwelt by Our God. Essentially, it all speaks on this wise, if there is to be enduring Foundations of the Nations, there must be a continuous bearing up of the Nation, on the hearts and mind of men and women of God. Finally, the ordered foundation is the place from righteous judgment and justice flows from and prevails in the land.

(ii) Ordering (1Timothy 2:1-6)

The main objective of this ministry is to aid in “Setting Divine Order in Order” within the church. That is, making the way straight by turning hearts to hearts and making the rod to bud. Achieving this objective is our daily pursuit by means of continuous ministering to the lord, engaging in continuous intercession and creating the atmosphere for the Holy One of Israel and The Spirit of Judgment. Setting the Spirit of Judgment (discernment) in the midst of the church will be paramount to this part of the mission.(Acts 13:2, Isa 40:3-5, Malachi 4:5-6).

(iii) Application

Having been assured that where is no prophetic vision, that is, evidence of the redemptive revelation of God and His person at work, the people will readily become defiant (immature), lawless (no restraint) and rebellious. This posture is known as the putting on of filthy rags as a form of righteousness. We have been mandated to foster an

atmosphere where vision and purpose is attainable, and can be pursued passionately without compromising the royal virtues. Being assured that this is the depth of the call, the application of the acts of intercession to its highest ideals and its most elastic application will be vital to produce the necessary revelation. Since this revelatory knowledge is key to understanding and possessing the knowledge of God, which is critical to us walking in the Spirit of Judgment. This is the necessary good, “For anything that goes unchecked in the earth is dangerous” and “where no judgment is, there prevails deception, seduction and the depth of wickedness.”

Prophetic

In the age when the greatest hunger is a hunger for effective leadership and for the Word of God. In an era when many have been bereft of understanding revealed spiritual authority, when many have designed a way so crooked and corrupt it repulses the hearts from turning to the heart; and when rogues have manipulated and appointed themselves leadership by their own arrogance, and when many are blinded by an elegance to a fading glory. In a period when pseudo and quasis bound by psychic phenomena want to rule the airwaves, control the marketplace and rule the lands. It is important to know that God has not left us without a witness; He knows how to deliver the Godly out of temptation, and He has appointed some, the spiritually mature to discern times and seasons. For the Spirit of Christ within them does search what and what manner of time events is appointed by God. These have clockwork built within them and are inspired according to his seasons. So then it is relevant to the foundation that we understand the times and have understanding of the times, so we can aid the nation to know what she ought to do. Timing then is synonymous to vision. (1 Chronicles 2:32). The cooperation being Prophetic in nature and prudent in application is given to inspire, provoke and give vision, interpret visions, to unveil dreams, unlock mysteries, while having a stewardship of the Knowledge of God, it will also give direction, speak as a heavenly spokesman in the earth for the Kingdom of God and bring men to Christ. It is the heavenly billboard to display the key of knowledge allowing many to enter the Kingdom of God.

(1) the Consortium*

As a CONSORTIUM it is an arrangement of elder statement, official Spokesperson/women joined together by graces, spirit, and anointing. As an institution it is a corporate Consortium of graduated mouthpieces having understanding in the protocols of the Kingdom, and their offices and then we will function on a developing and successional (continuous) basis. As a body it is an International Fellowship of Graduated Prophets (Quorum) and it will serve as a haven for Prophets/Prophetesses and other associates. As a society, it is a comforter for those who have been in the crucible of life. As a corporate spokesman it will serve both with a singular and collective voice, and as international Herald having the world as its pulpit. The Consortium will have the power to appoint mentors, apprentices and set them apart for the work wherewith they are called. It will operate on a local/state and national level with developed protocols and in its relationship with the media and general public.

In administration this entirety will be a magnet for the essential glory of God in a given environment. For they know that their God shall be strong and do great exploits! In Manifestation it is a “Spiritual Umbrella”.

Friends of The Family ***“..Do the will of my Father...”***

Friends are “Allies in the Struggle”, it implies one who knows what his master does; In association, one who is intimately acquainted and deeply involved with the honest heartfelt impulse of his friend, and by assertion, the most important relationship in the Christian family.

In order for a vision to reach its objectives people must become involved in its daily operation. Hence, friends of the family are these kinds of people. There is a kind of Christian who have died to self, having an understanding that the struggle is relative to every given individual and environment. In the fulfillment of this mandate we will continue to seek these friends as “ALLIES”.

Purpose

Throughout the earthly ministry of Our Lord Jesus Christ, many people aided Him by giving Him gifts worthy of Him; and appreciation for staying faithful as a steward in the mysteries of God, to anointing the calling and the ministry to help Him get to the next stage of the mission. This kind of support is invaluable since it is non-contractual but to the, the givers, they have made giving an essential way of their life. This allowed him the eternal opportunity to lay foundational testimonies that are apostolic messages to our age, of His silent partners of the bountiful generosity, that lives on into modern times. This kind of silent liberty abounded and prevailed much beyond those who religiously tithe without mercy and judgment.

If we are to successfully advance into the 21st century with the interest of Christ deeply rooted into our hearts then we must all continue to sow seed expecting a harvest. As was obvious then, all tangible and intangibles including miraculous supplies were given for personal use but they resulted in giving glory to God, justifying the saying “if all are made partakers of spiritual things, their duty is also to minister unto them in carnal things.”

All gifts then from these ALLIES would be used in a said manner to sustain the work of the ministry and its outreach. Primarily, Friends of the Family seeks ALLIES who would commit themselves to take their part in its operation. It seeks ALLIES who will commit parts of their income, personal/business profit, and otherwise financial intake on a weekly, biweekly, monthly, bi-monthly, quarterly, semi-annually, or annual basis to our care, for the work of the ministry.

Currently, the ministry is seeking 1000 ALLIES (men/women, churches or corporate entity) committing \$100.00 monthly to the ministry, a secondary string of ALLIES of 100 of the same entities to give \$150.00 monthly to the ministry for The Fielding of Generals into the mission field to increase the mission of evangelization, Holiness and commerce in the nations.

This will allow us to choose our Army and its Fighting power, that is, those that are trained and equipped with the choicest weapons, in our case, men and women who have goods. An additional string of 1000 ALLIES who would commit \$300.00 monthly is needed to advance the expeditions beyond training phase into implementation, supply and support.

Having these as an inner core ministry, having been bound and knitted together, by one spirit it can help to emphasize ways of sharing the ministry and its vision, operations, responsibilities, burdens and manifestations. This is the network of friends within the family performing similar or the same task at a specific instant of time, on a simulcast level with the same impact and intent.

Tithes

We fundamentally believe in the authority and power of the tithe that is giving of the 10th part of all increase in a commandment of obedience to God and His Laws, it being solely dedicated as Holy unto the Lord.

The ***Tenth part*** (the Tithe) being Holy dedicated unto the Lord has the following properties:

- It asserts the sovereignty of God
- It ascribe worship unto the Lord

- It is the intrinsically God's tax system within the church, and should not be administrated by civil authorities except in the case of breach created by ecclesiastical authorities. Ex: Nehemiah's administration as Governor of Israel and Lutheran Reformation, as a process to help rebuild the wall.
- It is a typical subject that has the exhaustive and revelatory properties
- It is God's ways and means of funding His projects
- It is God's provisional will for those in authority within the church
- It is His and our census guide and information gathering system (statistics) as Government of God
- It asserts that those that earn personal income by their God given strength should support God's efforts without withholding and by obeying His Government.
- It supports income gathering by this means to be uses solely as "meat in my house".
- It is directly consecrated for the use of the Priesthood
- It has inert powers to bind the hands of illegitimate authority
- It limits the boundaries of authorities
- It legitimizes church government as individual taxation legitimizes Civil government and personal income legitimizes Family Government
- It invokes blessing for obedience and curses of rebellion
- It has tenth power components and operates as an exponential function
- It is found in every religious system within the world and is sanctified in church as a sacrament that points directly to the gift that God gave to use, that is, Christ
- It is as ancient as iniquity
- It is legitimizes and consecrated by our forefathers: Abraham, Isaac and Jacob
- It is authenticated by Jesus Christ
- Its speaks directly of Christ, The root of the First Fruit, Himself
- It asserts financial discipline within the home
- It is covenantal from Generation to Generation, and should be practiced as such celebratory acts worship, as it is lifted to a higher order in the new covenant

We will continue in “THE INGATHERING OF MONEY, ALL NEGOTIABLE INSTRUMENTS AND GOODS” for the purpose of each individual projects of the ministry in Christ Kingdom (Paying the tenth part of all offerings to those that COVERS and are in covenant agreement with us.) But we will not engage in activities to raise more money than is needed for each individual project nor for unfounded situations. Any additional money raised above the budget's need will be automatically put to use in projects of “EQUAL IMPOTANCE”. In fundraising we will conduct ourselves according to rudimentary tenants of the scriptures that govern fundraising and the financial charities act of the network.

We will maintain accurate up-to-date record of the giver and the gifts. We will avoid “borrowing”, unreasonable debts, conforming ourselves to the patient practice of pay-as-you-go. We will continue by the Spirit of Christ and fervent in spirit, faith and business knowing that Christ is The Author and Perfector of our Faith and Life.

This then is “OUR STATEMENT OF FINANCIAL DECLARATION”, and our commitment is to the Lord, our ALLIES and OURSELVES. It is our intention to maintain financial integrity before all while in integrating Christi influence upon the society.
